B. Resolution - Opposition to FCC Draft Rule Allowing Cable TV Companies to Use PEG Grants to Offset Franchise Fees

WHEREAS, open government is a hallmark of free and democratic societies. An essential tool to ensure that government works in the best interest of its residents is the provision of Public, Educational and Government (PEG) channels provided by the cable television companies serving our communities; and

WHEREAS, in order to provide cable television service, providers must first obtain franchise agreements with the local municipality allowing them to construct their facilities on public rights-of-way; and

WHEREAS, in recognition of the billions of dollars earned by cable television companies during the terms of these franchise agreements, common terms in these agreements include the provision of franchise fees (typically a 5% charge for cable television services) and monetary grants for the purchase of equipment to produce content for the PEG channels (PEG Grants); and

WHEREAS, the Federal Communication Commission is considering a new rule which would allow cable consider to consider PEG grants as "in-kind" contributions which can offset franchise fees; and

WHEREAS, we believe that the two consequences of this rule change would be to further enrich cable providers and secondly the change would eviscerate residents ability to use cable access in furtherance of their first amendment rights; and

WHEREAS, such a rule, if adopted, would have a devastating impact on local governments throughout the country as it would eliminate an important non-property tax revenue, it could also lead communities to stop investing in or abandon their public access television programs in order to protect this important source of revenue; and

WHEREAS, the adoption of this rule could have a devastating impact on Larchmont-Mamaroneck Community Television (LMC-TV) as it is funded in large part through franchise fees and for decades has helped to ensure open and honest government by fostering an informed citizenry actively engaged with their civic institutions including their local governments and school districts, as well as promoting various other community activities which serve to meet the cultural, spiritual and educational needs of the larger Mamaroneck community; and

WHEREAS, in instances such as these where the basic tenets of open government are threatened, it is proper and appropriate that local elected officials affirm the importance of community television and protect vital sources of non-property tax revenue.

On motion of Trustee Waitt, seconded by Trustee Lucas:

RESOLVED, that the Village of Mamaroneck Board of Trustees hereby expresses its strong opposition towards any changes in federal regulation that would allow cable television companies to use PEG grants which are contractually obligated towards municipal governments to be used to offset franchise fees in any form or substance; and be it further

RESOLVED, that a certified copy of this resolution be submitted to the Village's federal elected representatives Senator Charles Schumer, Senator Kristen Gillibrand, Representative Eliot Engel, as well as the members of the Federal Communications Commission.
