In regard to the above captioned subject, the Village issued a Request for Proposals on April 29, 2019. It was posted on BidNet and sent to 232 vendors registered to receive notices of this type. A walk through was held on May 21, 2019 at which nineteen (19) vendors participated. On the response date, May 30, 2019, nine (9) proposals were received as follows:

Village Manager's office staff conducted an initial review of the proposals. As this is a professional service, the Village is not required to proceed with the lowest cost. Key factors in this analysis included: clear understanding of the project scope; professional expertise of the individuals assigned to this project; experience with similar projects, specifically site selection and design of public facilities; cost, etc.

After conducting this initial review, we recommend the following firms be shortlisted as their responses conveyed a clear understanding of the project scope, had significant experience with both site selection and design of public facilities (both public safety and administrative space)...
