Dear Sir:

We propose to provide the items of work in accordance with the specifications and requirements. The Village Manager will have final say in determining the location of all work to be performed as follows:

Work consists of the following – Parts 1 through 6 to be completed:

1. Complete trees – entire tree removed and carted away including branches and trunk, but excluding stumps which are to be removed by Village forces; based on unit prices
2. Tree Bole removal (remains from Con Ed tree-topping); excluding stumps which are to be removed by Village forces, based on unit prices
3. High dead branch removal, based on hourly rates, based on itemized Trees on a tree-by-tree basis.
4. Providing a total volume (in cubic yards), tonnage and recycling/re-use plan for all materials removed from the Village of Mamaroneck WITH EACH INVOICE FOR PAYMENT (such report is necessary for the compilation of the Village's Annual Recycling Report).
 - Bidder is responsible for maintenance and protection of traffic, at no additional cost to the Village.

Note: The Village of Mamaroneck has the right to make additions or deletions of labor and materials and may select or reject certain items, based upon Unit and/or Item prices bid.
