Part 2 – Tree Bole Removal – Utility Line Trunks (CETS)

Part 3 – Tree Trimming High Dead Branches

Part 4a – Emergency Road and Obstruction Clearing and Tree Removal (Mon. –

Fri. 8am – 6pm)

Part 4b – Emergency Road and Obstruction Clearing and Tree Removal (all other times)

Part 5 – Recycling/Re-use plan

WHEREAS, although there are multiple components to the contract, the award is based off Part 1 pricing as the rest of the contractual items are variable in nature and it is difficult to quantify the amount of work required; and
