Subject: Shared Services

Susan

Nancy asked that I respond to your e-mail in connection with shared services projects that are in the works. You should be aware of the following projects:

☸ Town of Mamaroneck/Village of Mamaroneck- Sanitary Sewer Camera Operations

The Town and the Village of Mamaroneck are working on a project where by the Town and Village will jointly purchase a sewer system camera and a vehicle on which the camera and associated equipment will be mounted.. The Town will assume the responsibility to operate the system and provide sewer line televising services to both the Town and Village. This program will allow for the purchase of one vehicle instead of two for compliance with our sanitary sewer maintenance programs. The capital cost of the project is \$171,000 and we are working on developing the operating cost at this time.

☸ Town of Mamaroneck/Village of Mamaroneck- Production of Salt Brine

The Town and the Village will jointly purchase the necessary equipment for the production and dispensing of salt brine. The equipment will be mounted in the Town Highway Department yard. Rather than each community purchasing the equipment, the Town and Village will purchase one brine system together. Town and Village salt spreaders will access the system and each dispense salt brine into the vehicles assigned to this task. The estimated equipment and installation costs are \$110,000. In addition to dividing the capital purchase and installation costs, each community will pay for each gallon of brine actually used.

❁ Town of Mamaroneck, City of New Rochelle, Village of Pelham Manor and Village of Larchmont – Sewer District Consolidation

The four communities will soon complete a comprehensive restoration and repair of their sanitary sewer systems. With the sewer systems fully restored and a significant reduction in the infiltration and inflow of storm water, it is a good time to discuss with Westchester County the possible consolidation of the New Rochelle Sanitary Sewer District. The communities and the County did start this initiative in 2017. A preliminary report was prepared by Arcadis Engineering listing a number of options for a sewer district consolidation. The communities would like to restart this process to evaluate the shared service program that could be developed. A consolidated sewer district is expected to be more efficient and a better value for the taxpayers.

All of these programs are considered excellent shared services projects and should be endorsed for funding in the County's shared services submission to New York State. If you need further information on any of these programs, please let me know.
