3. Comments From Residents:

Stuart Tiekert recommends prioritizing tree inventory plan, Jerry to hire interns; removing two trees on Post Road in order to plant new trees further back VOM will prune existing trees instead; tree topping violation for 532 W. Boston Post Rd was sent; recommends removing mature Linden trees on Carroll Ave-Jerry to assess.

Wendy Li, 1001 Shore Acres Drive: new tree to be relocated due to upcoming renovation.

Sophie Belin asked for pruning tree on property line with VOM. DPW determined it is her tree.

Sean Gormley asked for tree to be evaluated on English Pl.

Wendy Zoland asks for small tree to be moved to other side of street. Bleeker and Orienta

Larry Cohen would like trees next season on Van Ranst and Sheldrake near Columbus Park.

Old Business:

Evergreen tree at 1533 Raleigh Rd. with V-cut pruning by Con Ed be evaluated by VOM.

Palmer Avenue across from Sand St. sassafras tree obstructing sidewalk. Order to remedy was issued and tree has been pruned.

Hazardous tree at 725 The Parkway median evaluated.

Building owner Spadaro replacing trees obstructing fire escape at Florence and Halstead.

Fall planting update: 106 trees by Nov. 30. Sites marked; Sean to mark sites for Mangone trees.

Citizen Pruner's Workshop attracted about 12 people. Very successful. October 26, 2019

Ordinance Update: village attorney to submit revised document to TreeCom by December 5. Will ask about imposing fines on tree companies for violating ordinance.
