COMMUNICATION TO THE BOARD - Suggested Time Limit on Comments of 5 minutes

A. CTB I

Mr. David Styler appeared on behalf of the Committee for the Environment to announce a leaf mulching demonstration that will take place on Saturday, December 16, 2019 on the corner of Prospect and Mt. Pleasant Avenues. He also spoke about the benefit of mowing leaves back into your lawn. The Village is taking part in the Love 'em and Leave 'em program.

Mr. Martinelli appeared regarding an email he sent describing an event that happened one morning at 6 a.m. He heard a woman screaming and when he went around the corner from his home, saw a large coyote in the middle of the street. It was following a woman and her 50-pound dog. He yelled and threw sticks at the coyote until it left her and started to approach him. He did get away and into his home without incident. It is apparent that coyotes are not afraid of humans. This is a disaster waiting to happen. Multiple coyotes are traveling together and are concentrated in a small area around Florence Park. Residents are walking the streets with weapons. Today was the first time that the school said anything to their students. Mayor Murphy stated that he was informed of this by the Rye Neck Schools Superintendent.

Mayor Murphy informed the residents that the Village will be applying for a permit to remove coyotes if necessary and the Board will be forming a committee to look at this issue at their November 25 meeting. Residents were asked to send in a note of interest to the Village Manager if they would like to be part of the committee. They were also asked to send any coyote incidents to the Village Manager, Mr. Barberio.

Other Rye Neck residents appeared regarding their sightings/encounters with coyotes. It was also noted that there are rumors of residents feeding the animals. This should absolutely not be done. The Village is cutting the grass of vacant homes to try to curb coyotes from making their dens in tall grass.

Ms. Franca Demalo of Mt. Pleasant Avenue appeared. She stated that no one is enforcing the parking regulations in that area. There is nowhere for the residents to park. Employees from the local businesses are parking on the street for more than the 2-hour limit. Also, residents of Sweetwater are getting on-street parking permits. This information will be relayed to Chief Leahy.

Mr. Glen Tippett appeared regarding the last Zoning Board Meeting where members of the ZBA asked a business (Chipolte) going into the old A&P site what kind of money they make. They have no right asking this of a restaurant. Other member stated that Chipolte was a different type of business and should be looked at differently. They are currently in the deliberation stage of the Special Permit review for this application. Mr. Tippett state that the ZBA cannot go outside of what their purview is and if they do, will be sued for spot zoning.
