WHEREAS, this position requires 20 hours a week at an hourly rate of \$35.00 for 18 weeks, resulting in an additional salary expense of \$12,600.00 to General Fund budget line A.7230.0110; and

WHEREAS, since June 15, 2020, the weekly hours for the part-time Harbor clerk, Kristen Salov, have increased from 18 to 37.5 hours weekly, which will continue for 4 months through October 15, 2020 as regulated by Civil Service; and

WHEREAS, Ms. Salov's increase of 19.5 hours a week for 18 weeks at an hourly rate of \$24.30 will result in \$8,530.00 of additional salary expense to General Fund budget line A.7140.0120; and

WHEREAS, such additional expenses will require funding of the budget lines noted to be appropriated from Fund Balance.

B. Resolution Authorizing Budget Transfer for Crossing Guard Salaries

RESOLUTION RE: RE: AUTHORIZING BUDGET AMENDMENT TO FUND SCHOOL CROSSING GUARD SALARY BUDGET LINE

WHEREAS, the Village of Mamaroneck employs School Crossing Guards to ensure the safety of the residents and students walking to and from the Mamaroneck Public Schools; and

WHEREAS, due to the COVID-19 pandemic and current NY State requirements to maintain proper social distancing, the Mamaroneck School District has adjusted the 2020-21 daily school schedule to incorporate a "split-shift" schedule to reduce attendance at each school location at any given time; and

WHEREAS, the "split-shift" daily schedule will create an additional mid-day student crossing at nine (9) school locations, resulting in an additional budgetary expense of \$35,000 for the School Crossing Guards that were not anticipated in the adoption of the 2020-21 budget; and

WHEREAS, the Village has recognized a savings of \$21,000 in June 2020 due to reduced School Crossing Guard staffing for the remainder of the 2019-20 school year, which will be used as an offset; and

WHEREAS, a budget amendment is being requested in the amount of \$14,000 to increase budget line A.3120.0130 School Crossing Guard Salaries for the difference needed to fund the remainder of the 2020-21 budget period.

Mayor Murphy took the next item out of order as there were many individuals in attendance to speak on it.

- 4. NEW BUSINESS Time Limit on Comments of 3 minutes
- D. Resolution Authorizing the Painting of a Black Lives Matter Mural on Madison Street

Ms. Rita O'Connor, lifelong resident appeared. She believes that painting this in a section of the Village that is not centrally located presents an issue. Why not put in a central location representing all groups that have contributed. Don't take political stance with one group. There is a better way to support the cause.

Ms. Susan Deshensky appeared. She believes that if the Board is going to do for one group, should do for other groups that support other causes. Need to listen to other groups equally.

Mr. Robert Miceli appeared and stated that this is a direct result of the Mayor being more concerned with this issue then remembering those lost on 911. He cannot sit by and watch the hypocrisy and divisive

views that are tearing individuals apart. Read the Village Code 123.1 which states that a block party should not include a political meeting or rally. These are Marxist ideologist ideals that support the democratic party. Since the march on June 5, there have been 3 illegal demonstrations. No permits were filed for these events. Leaders are putting politics before public safety. Need to protect all of us equally.

Ms. Laura Abatte appeared. She is no stranger to diversity as diversity has never changed Washingtonville. Different races and ethnicities have always lived side by side. This neighborhood cannot continue to shoulder or burden issues that have not been resolved. Putting a mural in one specific small part of town where homes are continuously jeopardized is not fair or just. What about painting lines for parking spaces? This will also be too expensive to upkeep. She is already opposed to the mural on Waverly Avenue that was painted three years ago. If this mural is painted in Washingtonville, how with the Village ensure safety? It should not be the Boards position to take a stance on social issues. They are elected to maintain taxpayer dollars. Not to take a political stance on an issue like this. Is this the only section in the Village that African Americans live? Most diversified part of town. Why not put in Harbor Island where it can be supported or in front of the Regatta. Paint it also in Shore Acres, Orienta and Harbor Heights.

Mr. Glen Tippett appeared and asked if community members asked for this and will they be paying for it? He was told that they did and are. Village is not paying for. He stated that there is a difference between the movement and the Black Lives Matter organization. Perhaps make it temporary. Allow other groups to put messages in other parts of the Village. Doesn't see a problem. Must be emphasized that this is separate from the organization.

Ms. Tracy Dickerson appeared. She is also a lifelong resident. Thinks that it is an awesome idea. This neighborhood throws a party every year, that everyone in Washingtonville is invited to. As this party cannot happen, this neighborhood group asked to have this mural painted instead. Something is obviously happening if protests are going on in the Village. Asking for everyone to join together and show support, instead she is feeling hostility. She agrees with separating the issue from the organization. Putting at Harbor Island is a phenomenal idea.

Mr. Jim Abatte appeared. He understands that a handful of people are going to do the right thing but have to look at protests and much have been negative. Not just going to have residents of Mamaroneck be here. Not safe in residential area. He would support if done the right way. Agrees with putting at the Harbor. The Washingtonville community did not discuss or want it. There are people who are not going to do the

right thing and is concerned that we cannot control that. Would like to see blue lives matter get respect. Important to recognize everyone.

Mr. Jarret Winchester appeared. He is the resident who proposed the idea. Opposition has wrong idea. For 15 years, a group of neighbors ran a block party to help the neighborhood kids going to college. Two years ago, they had shirts printed that said all lives matter. This is fundraising for Mamaroneck children. Never meant to be divisive. As they cannot have a block party this year, they asked to paint this and by invitation only. Not opposed to residents putting other signs in the street. No such thing as a blue life. Not what this is about.

Mr. Damon Romanelli appeared and stated that there is nothing more divisive right now than the BLM movement. He lives in the flats and every time something is going on, it is always put in this neighborhood. There are so many important issues that are not being addressed, but this is getting pushed along. People are going to come to see. Why not do in another community. Why not Orienta, Shore Acres? Should be in a different area. On Mamaroneck Avenue or Harbor Island.

Trustee Wenstrup believes that the BLM movement and the way it started is the civil rights movement of our time. There are residents who want to paint these words in lieu of having a block party. It breaks her heart to have this divide the neighborhood. She hoped that it could be a positive thing for the community. Doesn't necessarily bring violence. She supports it.

Trustee Lucas admitted that the BLM movement is something she can't really understand, as she cannot walk in other's shoes. The Board needs to also respect traffic, activity in their neighborhood. Can we do in a place that more people could see. Believes that it cannot be permanent. Perhaps something that we can do as a community for the community.

Trustee Natchez stated that he is a big civil rights person and that this is a comment, not just a mural. Concept was to do something collectively together. Words can be misinterpreted. Mural concept was good.

Trustee Tafur believes that this is well intended. Key for the Board to determine is can we guarantee the safety and deny that it is political. Will have to accept other proposals along the same line. He needs to hear about specifics. This will require an even-handed approach. This is an important moment where people want to express themselves and the Board must be fair on what they allow. What is being requested goes beyond a mural; it is a statement. Cannot guarantee that it is only a statement and not supporting the organization.

Trustee Tafur stated that what the Board has in front of them does not explain anything. No guarantee that it will not be out of control. This must happen in an organized way. Still too controversial.

Mayor Murphy stated that he is glad members of the neighborhood came out and voiced concerns. Understands their concerns but doesn't hold the same views. He grew up in a diverse but segregated neighborhood. These are important words and are not saying that other lives do not matter. For 400 years African American lives did not matter, and they have been trying to tell us that. Violence has been blown out of proportion. Not near comparable to what happened during the civil rights movement. This Country has had the same conversation about race since he was a little boy. He wants to move past that, demonizing people. We have a large community that has been saying that they should be allowed to reach their potential. This has nothing to do with political persuasion. To say that this divide is gone, and all is good is putting your head in the sand. Mayor Murphy also informed the Board that if they approve this, they do not have to entertain everything that comes along.

Trustee Natchez made a motion to amend the Resolution to stated that a mural without words will be painted and to also strike BLM and add that it will be painted with temporary paint. There was no second.

Trustee Tafur believes that either this proposal be allowed, or impose conditions to the proposal. He does not think that this Resolution is ready for the Board to adopt.

The Board agreed to continue this discussion at the September 29, 2020 Work Session.
