WHEREAS, the Board of Trustees encourages the mural organizers to work with other community groups to make this an inclusive and diverse community event.

WHEREAS, the Board of Trustees agrees to formally accept the donation of paint and in-kind donation

of labor of village residents to paint the mural and Village will facilitate the timing of the painting, the details of the production of painting, the closing of the street and any other details as may be needed to accomplish the painting.

~~WHEREAS once the in-kind donations and the event are finalized, it will come back to the board for formal acceptance of the donation as required by law.~~

WHEREAS, the painting of the message will not be regarded as semi-permanent or permanent. The painted street, may be repaired, maintained, repaved, replaced or repainted over,
