**RESOLUTION RE:
COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM
PHASE I MAMARONECK AVENUE SCHOOL PEDESTRIAN IMPROVEMENTS**

WHEREAS, Community Development Block Grant Applications must be submitted to the Westchester County Department of Housing and Community Development for inclusion in the application submitted to the U.S. Department of Housing and Urban Development for Community Development Block Grant Funding; and

WHEREAS, during the new CDBG funding cycle for federal fiscal years 2022, 2023, and 2024, the Village is limited to submitting no more than four (4) application, each with a maximum funding request of \$250,000, and

WHEREAS, the Village is seeking to submit an application for Phase I of the Mamaroneck Avenue School Pedestrian Improvements as part of a five-phase series with a scope of work to include the following:

- Construct 2 bulbouts with ADA ramps at the intersection of Mamaroneck Avenue and Elliot Avenue.
- Drainage improvements for existing catch basins displaced by bulbouts.
- Reconstruct sidewalks on the north side of Mamaroneck Avenue between Elliot Avenue and Gertrude Avenue.
- Construct a new section of sidewalks on the north side of Mamaroneck Avenue between Gertrude Avenue and Bradford Avenue
- Install an ADA pedestrian ramp at the northeast corner of the Mamaroneck Avenue and Gertrude Avenue intersection.; and be it further

and

WHEREAS, estimated cost of this phase is \$418,000 with a grant funding of \$209,000 to be matched by a the Village; now therefore

RESOLVED, that the Board of Trustees of the Village of Mamaroneck does hereby authorize the submission of an application to the Westchester County Urban Community Development Program for the

funding cycle for federal fiscal year 2022 through fiscal year 2024 to implement Phase I improvements as part of a five-phase series:

RESOLVED, that the Board of Trustees of the Village of Mamaroneck does hereby commit to providing funding of up to 50% of the estimated amount totaling \$209,000 to the project that is the subject of the Community Development Block Grant; and be it further

RESOLVED, that this project addresses a definite need in the Village pursuant to Article 15, Section 502 (4) of the General Municipal Law as established by resolution of the Board of Trustees dated August 11, 1997.
