I had previously sent you the contact information (below) for the USGS representative (in July and previously) that wanted to work with the Village to reinstall the river gauges that were removed from the Mamaroneck and Sheldrake Rivers before the Army Corp did their planning project.

We have been blessed the last two storms that the village was not decimated in covid floodwaters – as we know raw sewage contains covid and our floodwaters contain sewage.

There is no reason that can justify in 2021 with the technology available that we are not working with the USGS to install gauges that will notify people on their smartphones, or otherwise of rising imminent flash flooding. We have the escape route up old white plains blocked because of bridge repair and now Hillside being blocked because of bridge repair. All residents in the flood plain are literally sitting ducks who cannot evacuate in a flash flooding situation. Many new residents in the Flats renting in the new developments are unaware of how fast the waters flood, even that they flood, and which roads to take to safety because flooding is all around them when it happens. In fact the e-mail and phone calls recommended heading out in the dark into flooded streets. It made no sense to those of us who know how fast people walking or in cars can get caught up in the flash flood waters of the Mamaroneck and Sheldrake. The latest village evacuation notice did not include directions, or even offer an evacuation location. I thought we had evacuation plans in place.

The technology is easily installed in our rivers. It is ONLY A MATTER OF WILL OF THIS BOARD.

Are you working with the USGS now? If not, why wouldn't you want to provide the highest level of technology available for the safety of Village residents and our first responders? Does someone have to die again?
