**RESOLUTION RE: AUTHORIZATION TO EXECUTE A PROFESSIONAL SERVICES
AGREEMENT FOR STRUCTURAL ENGINEERING SERVICES FOR THE MAMARONECK
WASTE TRANSFER STATION ROOF**

WHEREAS, several years ago, the Village demolished a brick building and roof over the Village trash compactor located at 313 Fayette Avenue as the roof had been structurally compromised due to a lack of clearance for sanitation vehicles to tip their packers and dump refuse, rubbish and recyclables; and

WHEREAS, the Village is desirous of replacing the roof structure to limit the compactor's exposure to the elements which will limit its useful life, as well as providing a safer working for Village Department of Public Works Staff; and

WHEREAS, the Village asked are consulting engineer, Kellard Sessions, to solicit a proposal for structural engineering services for a pre-fabricated structure in order to complete the design and engineering for this project; and

WHEREAS, by resolution dated May 24, 2021, the Board of Trustees authorized the execution of a professional services agreement for structural engineering services with Grossfield Macri Consulting Engineers Inc. (GMCE) for such work in the amount of \$16,800; and

WHEREAS, as a result of the flooding caused by Hurricane Ida, staff is desirous of revising the project scope to include additional security and resiliency features as well as account for the increasing height of the newest dump trucks; and

WHEREAS, based on this, the Village asked its lead engineer on the project, Kellard Sessions consulting structural engineer, GMCE to review and revise their proposals; and

WHEREAS, as the changes in scope affect the structural engineering aspect of roof and building replacement aspect, there is no change in the Kellard Sessions Proposal, however, GMCE submitted a revised proposal in the amount of \$31,800 to incorporate the desired improvements to enhance the long-term operability of the facility as well as the continuity of operations needed during emergency incidents;

NOW, THEREFORE BE IT RESOLVED, that the Village Manager is herein authorized to execute a professional services agreement with Grossfield Macri Consulting Engineers, Inc for structural engineering services for the Mamaroneck Waste Transfer Station Roof Project in an amount not to exceed \$31,800; and be it further

RESOLVED, that all such costs associated with this work be charged to A.1440.0421; and be it further

RESOLVED, that the Village Manager is herein authorized to undertake such administrative acts as may be necessary to effectuate this work.
