The proposed expansion is in violation of: Article VI, §342-38 of the Village code where the allowed building coverage is 22,078 sq. ft. and the Applicant proposes 25,834 sq. ft.; Article VI, §342-38 where the percent of lot coverage allowed is 50% and the Applicant proposes 59%; Article VI, §342-38 where the maximum FAR allowed is 1.0 and the Applicant proposes 2.43; Article VI, §342-38 where the maximum gross floor area allowed is 44,156 sq. ft. and the Applicant proposes 107,087 sq. ft.; Article VI, §342-38 where the maximum number of stories allowed is 3 and the Applicant proposes 4; Article VI, §342-38 where the Front/Fenimore Rd. setback required is 10 ft. and the Applicant proposes 7.8 ft.; Article VIII, §342-56 where the number of required off-street parking spaces is 137 and the Applicant proposes 25; and Article VIII, §342-57 where the number of required off street loading spaces is 8 and the Applicant proposes 4. (M-1 District)
