RESOLUTION RE:

RESCINDING NO PARKING RESTRICTIONS ON EAST BOSTON POST ROAD (U.S. ROUTE 1)

WHEREAS, the Co-op located at 901 Stuart Avenue is planning to rehabilitate their parking structure beginning on June 1, 2023; and

WHEREAS, representatives from the Co-op appeared at the May 9, 2023 Board of Traffic Commissioners meeting and reported that this would displace approximately 25-30 vehicles; and

WHEREAS, these representatives requested that the Village allow vehicles to park on East Boston Post Road in front of the building for the duration of the construction for the benefit of their residents; and

WHEREAS, staff noted that while the existing parking restrictions it would be open to all as the Village staff cannot limit on-street public parking to residents of 901 Stuart Avenue; and

WHEREAS, the Traffic Commissions reviewed this request and recommended that existing parking restrictions be lifted for the area of on the south side of East Boston Post Road generally located between Sophia Street and Stuart Avenue, with said restriction to be restored upon the issuance of a certificate of occupancy for the renovated parking garage.

NOW, THEREFORE BE IT RESOLVED, that the following amendment to Chapter 326 (Vehicle & Traffic Law) of the Code of the Village of Mamaroneck is hereby amended as follows.

Section 88 Schedule XXI: Parking Prohibited Certain House.
