Good Morning Jerry,

Please see answers to your questions below.

*Jason, when was the last time we used or asked to use district fields?* **The Recreation department does not use Mamaroneck district fields or property. Individual leagues permit MHS when space is available. MHS modified, JV, Varsity sports get priority. I know the MHS director does her best to accommodate local leagues if the space is available.**

*Are we permitted to use fields at Rye Neck HS?* **The Recreation department does not use Rye Neck district fields or property. From my understanding Rye Neck is not as generous as MHS with athletic field space or indoor space. The leagues have not had as of an easy time working with Rye Neck SD on renting field space. I am told the new superintendent in Rye Neck might be more accommodating than the previous superintendent (absorbent rental rates and janitorial expenses are potential barriers to entry).**

*Do we coordinate with other municipalities when we receive full season youth sport requests?* **We do not currently coordinate our field requests with other municipalities. The Mamaroneck school district used to have arena scheduling meetings where the local leagues, and municipalities (VOM, TOM, and Larchmont) would work through any permit issues (Rye Neck SD was not part of these meetings). We have not had an arena scheduling meeting since 2019.**
